1. Print neatly, complete all sections of the form and include your phone number.
2. You and your legal guardian will need to READ and SIGN the application.
3. Include a **CHECK** payable to "5th Grade Pass Program" for **\$15.00**. This fee helps cover cost to process the application and sending you your Pass.

That's it! We will do the rest. Please allow two to four weeks to receive your Pass. If you send the application before the ski season you will not receive your Pass until the first week of November. Have fun and ski and ride safely!

Pass Rules and Regulations. Your Pass will not be valid and sent until this signed agreement is on file.

1. Yellowstone Receptions Foundation a.k.a. Sleeping Giant Ski Area is providing 5th Graders with a 5th Grade Pass. The pass is a non-transferable document which entitles the 5th Grader to whom it is issued (Holder) a complimentary student's one-year ski pass, subject to the terms and conditions set forth below, during the 2010-2011 ski season.
2. The purchase of an adult ticket is not required, individual or groups of children must have adult supervision while at the ski area. If the supervising adult skis, an adult lift ticket must be purchased. Ski Area reserves the right to withhold daily lift privileges if Pass holders fail to identify adult supervisor(s).
3. The Pass may not be transferred or sold to any other person, including family members. The Pass will be immediately revoked if Holder transfers use of Pass or any lift ticket obtained with Pass to another person.

4. THE LEGAL GUARDIAN/PARENT OF THE PASS HOLDER UNDERSTANDS THAT THE PASS HOLDER IS UNSUPERVISED AT ALL TIMES DURING THE DAY. THE PASS PROGRAM IS NOT A SKI SCHOOL LESSON PROGRAM OR DAY CARE PROGRAM.
5. The Pass will be revoked and canceled without notice for any misuse. Holders and the parent or legal guardian are responsible for proper use of the Pass at all time. In the event of Pass misuse and cancellation, Sleeping Giant Ski Area may recover damages from Pass misuse, including reasonable attorney fees.
6. The Sleeping Giant Ski Area reserves the right to modify or cancel the Program and all valid Passes at any time without notice. The Sleeping Giant Ski Area is not responsible for expenses incurred or opportunities forgone by cancellation or modification of the Program.
7. If a Pass is lost or stolen, notify the office immediately. We reserve the right to make case-by-case determinations concerning replacement of Pass.
8. All Pass Holders agree to comply with all rules and regulations of Sleeping Giant Ski Area and with all other applicable laws and regulations, including Wyoming inherent risk of skiing statutes.
9. All information in the application is subject to verification. All information in this application becomes the property of Sleeping Giant Ski Area. Sleeping Giant Ski Area may use information provided by Pass applicants.
10. We further agree to RELEASE FROM LIABILITY and to INDEMNIFY AND HOLD HARMLESS the organizers and sponsors of this program, Yellowstone Recreations Foundation, Yellowstone Recreations L.L.C., Sleeping Giant Ski Area; and their owners, members, agents, insurers, landowners, affiliated companies, employees and volunteers for any damage, injury or death to myself or to any person or property, whether caused by their NEGLIGENCE or for any other reason, in any way connected with my participation in this program

We fully understand the terms of the 5th Grade Pass Agreement and agree to comply with all the rules set forth above. We understand that any misuse of the Pass or ticket obtained with the Pass will result in revocation of the Pass.
