In consideration of my participation, I hereby release and covenant not to sue Yellowstone Recreations, LLC dba as Sleeping Giant Ski Area and Zipline and any of their employees, coaches, agents or volunteers from any and all present and future claims resulting from ordinary negligence on the part of Yellowstone Recreations, LLC dba as Sleeping Giant Ski Area and Zipline or listed property damage, personal injury, wrongful death arising as a result of my engaging in or receiving instruction for the Sleeping Giant Ski Bus Program activities or any activities incidental thereto, wherever, whenever, or however the same may occur. I hereby voluntarily waive any and all claims resulting from ordinary negligence, both present and future, that may be made by me, my family, estate, heirs, or assigns.

Further I am aware that the Sleeping Giant Ski Bus Program involves certain risks which may result in various physical injuries, as well as the possible reckless conduct of other participants, and participation at sites that may be remote from available medical assistance. I am voluntarily participating in this activity with knowledge of the danger involved and hereby agree to accept any and all inherent risks of property damage, personal injury, or death.

I further agree to indemnify and hold harmless Yellowstone Recreations, LLC dba as Sleeping Giant Ski Area and Zipline, and others listed for any and all claims arising as a result of my engaging in or receiving instruction for the Sleeping Giant Ski Bus Program activities or any activities incidental thereto, wherever, whenever, or however the same may occur.

I understand this waiver is intended to be broad and inclusive as permitted by the laws of Wyoming and agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect. I further agree that the venue for any legal proceedings shall be in Wyoming.

I affirm that I am of legal age and am freely signing this agreement. I have read this form and fully understand that by signing this form I am giving up legal rights and/or remedies which may be available to me for the ordinary negligence of Yellowstone Recreations, LLC dba as Sleeping Giant Ski Area and Zipline or any parties listed above.
